

2024 PAVILION GUIDELINES

Background: The pavilion was built in 2003 and is intended solely for use by the residents of Battlefield Green and their supervised guests.

General Guidelines: Only eligible BGCA members (Rec fee paid & current on dues), or guests under the direct supervision of a resident 21 years or older, may use the pavilion without the express written consent of the Battlefield Green Board of Directors.

Reservation Guidelines: An eligible BGCA 21 years or older member may reserve the pavilion free of charge for a period of time not to exceed the hours of operation during any single day within a 72 hour period. No more than 2 reservations are allowed per homeowner in a calendar year.

The request to reserve the pavilion will be made in writing during the normal business hours posted for the clubhouse at least 3-days in advance of the reservation date. There is a \$50.00 refundable deposit required for reservations. Upon approval, the member will be given notice confirming the reservation period and a copy of this notice will be predominantly posted prior to the rental period. If the pavilion has not been reserved, it will then be available on a first come, first serve basis by eligible BGCA members. Loitering at or around the pavilion is not permitted.

When reserved in conjunction with a paid reservation of the clubhouse or pool, there will be an additional fee of \$50.00 to reserve the pavilion.

The playground equipment is restricted to age appropriate residents and guests only.

No bikes or pets are permitted in the pavilion or playground areas.

Hours of Operation: The pavilion may only be used during the following times:

Sunday-Thursday	10AM to 10PM
Friday-Saturday	10AM to 10PM

Upkeep and maintenance: It is the responsibility of the homeowner who reserves the pavilion to ensure it is adequately cleaned after each use. This should include removal of any and all items attached to the foundation of the structure. No glass bottles or glass products are permitted in the pavilion/playground area.

When reserved in conjunction with a rental of the clubhouse or pool; if upon inspection, the pavilion is found not adequately cleaned; a \$50.00 fee will be deducted from the rental deposit for this service.

For members reserving the pavilion that is not in conjunction with a rental of the clubhouse or pool; if upon inspection by any Battlefield Green Board of Director or representative, it is determined that adequate cleaning was not performed, the members will be asked to return to the pavilion and clean the area. If the homeowner does not adequately clean the pavilion, they will forfeit their deposit as a cleaning fee and will be prohibited from using the pavilion for a period of six-months.

Misuse: Inappropriate use of the pavilion may result in criminal prosecution and/or an assessment to cover costs incurred to repair the pavilion or surrounding areas.
